INSTRUCTIONS

Reference: Chapter 4 Division 10 §4.193(e)

WHO MUST FILE

A person who transports oil & gas waste for hire by any method other than by pipeline off a lease, unit, or other oil & gas property for disposal is required to have a waste hauler permit per §4.193 (a)

NOTE

The term "**vehicle**" used in Form WH-2 refers to any truck, tank, trailer tank, vacuum tank, dump truck, garbage truck, or other containers used to transport oil and gas waste by the waste hauler.

If the total entries exceed the available space on the form, complete additional Form WH-2s.

COMPLETING THE WH-2

The Form WH-2 is completed by the waste hauler operator and submitted with Form WH-1 for an initial application.

The Form WH-2 can be submitted by itself to **add or remove** vehicles to an existing permit.

Enter the **Vehicle VIN** and **license plate** that are listed on the current vehicle registration.

Enter the **total capacity** for the hauler.

Indicate the units used for the total capacity, **Cubic Yards** for **solids**, or **Barrels** for **liquid**.

If the vehicle (hauler) **is registered outside of Texas**, submit a copy of the current vehicle registration when filing.

Check the appropriate box to indicate if the vehicle is being **added** or **removed**.
