GATHERING CHARGE: Where gathering service is performed by Plains at point of origin, a charge of [I] 67.10 cents per barrel will be made in addition to the transportation rate named herein.

SPECIAL GATHERING CHARGE: A special gathering charge of [I] 94.60 cents per barrel will apply to those barrels of crude petroleum gathered from the Levelland C Lease into Sundown Station.

At Cedar Lake, Sands Station and Slaughter, Sundown Station, a [i] 44.00 cent per barrel incentive gathering charge will apply to barrels of Crude Petroleum gathered in excess of 4,000 barrels per day by a shipper. The barrels per day will be calculated based on the monthly volume.

HAND RUN GAUGING FEE: There will be an additional charge of [I] 22.00 cents per barrel on gathered Crude Petroleum which is hand run gauged.

[W] UNLOADING CHARGE: Shipments unloaded from tank truck facilities into Carrier gathering facilities will be subject to the Gathering Charge. All shipments unloaded from tank truck facilities into the mainline facilities of the Company will be subject to a charge of [N] 7.22 cents per barrel.
