NOTES TO RATES TABLE

- 1. The Committed Rates set forth herein are available as of October 1, 2022 for any shipper that signs a Transportation Services Agreement with Carrier and agrees therein to make an acreage dedication for at least seven years.
- 2. [N] Any shipper that enters into a Transportation Services Agreement with Carrier and agrees therein either to (i) ship or otherwise pay Carrier for failing to ship a specified volume of crude oil or (ii) dedicates certain production for delivery to Carrier's system, in each case, for a period of at least one year, may qualify for a Committed Shipper Rate for the movement. Interested shippers should contact Carrier for more information.

UNLOADING CHARGE (applicable to all movements under this tariff): All shipments unloaded by tank truck into Carrier's mainline facilities will be subject to a charge of **[I]** ten and eighty-two hundredths cents (\$0.1082) per barrel in addition to the transportation rates named herein.

INCENTIVE RATE PROGRAM

Any shipper that ships 25,000 barrels per day or more during a month under the Base Rates set forth in this tariff, as measured on an average daily basis, shall be charged \$0.00 cents for all of its movements during the month under this tariff; movements made by a Committed Shipper in a month under the Committed Shipper rates do not count towards qualification for the Program. Carrier shall consider barrels that the shipper ships at the Base Rate under (i) Arrowhead Eagle Ford Pipeline, LLC's TRRC Tariff No. 2.34, (ii) Arrowhead Eagle Ford Pipeline, LLC's TRRC Tariff No. 2.19 (or

subsequent reissues thereof) in a month, in addition to barrels the shipper ships under this tariff at the Base Rate, to determine if a shipper meets the requirements for this incentive rate program for the month.
