

AMENDMENT NO. 1
CONTRACT NO. 455-24-1007 FOR
INFORMATION TECHNOLOGY SERVICES
BETWEEN
THE RAILROAD COMMISSION OF TEXAS AND
GWPC'S RBDMS®

THIS AMENDMENT NO. 1 to Contract No. 455-24-1007 ("Contract") is entered into by and between the State of Texas, acting through the Railroad Commission of Texas ("RRC"), located at 1701 N. Congress Ave., Austin, Texas 78701 and Ground Water Protection Council, Inc ("Contractor"), located at 13308 N. MacArthur Boulevard, Oklahoma City, OK 73142 (individually, "Party"; collectively, "Parties").

WHEREAS, SECTION 7.09. of the Contract provides the Parties may amend the Contract through written agreement; and

WHEREAS, the Parties desire to further amend the Contract terms to their mutual benefit to reflect changed circumstances.

NOW, THEREFORE, the Parties agree to amend the Contract as follows:

- I. **SECTION 2.01. CONTRACT AWARD.**, subparagraph (a.) is deleted in its entirety and replaced with the following:

"This Contract shall be effective September 1, 2023, through August 31, 2027 (the initial term of the Contract plus the exercised optional renewal term one of two; collectively, "Contract Term") unless terminated earlier as provided in RFO No. 455-23-1007 Part III and/or section **2.02 TERMINATION.**, set forth below.

This Contract may be extended only through written amendment to the Contract, fully executed prior to the expiration of the Contract Term in effect prior to execution of the applicable Amendment to the Contract.

RRC reserves the right to renew the Contract for one (1) additional, one-year renewal term remaining of the original one (1) two-year and one (1) one year renewal terms as set forth below:

Second Optional Renewal Term: September 1, 2027 – August 31, 2028"

Except as expressly amended above, all provisions of the Contract, as amended, remain in full force and effect. In the event of a conflict among provisions of the Contract, the order of precedence shall be: this Amendment No. 1; and then the original Contract in accordance with section **1.03. ORDER OF PRECEDENCE.**, therein.

IN WITNESS WHEREOF, the Parties hereto have made and executed this Amendment No. 1 to the Contract to be effective as of the date of the last Party's signature hereto. By signatures below, each signatory represents and warrants that they have the authority to amend the Contract on behalf of the respective Party.




