- 1. The Karnes City Truck Unloading Facility is not part of the Pipeline Operator's System. Therefore, in order to use the Karnes City Truck Facility to access Pipeline Operator's System, a shipper must make arrangements with the third-party licensor of this facility.
- 2. The Committed Rates are available to any shipper that signed a TSA with Pipeline Operator for a ten year initial term and dedicated therein at least 95,000 acres.
- 3. The Uncommitted Rates are applicable to all shippers who do not qualify as a Committed Shipper.
- 4. In the event that a Committed Shipper nominates and delivers in excess of 60,000 barrels per day (on an average daily basis) from any origin point to any destination point listed herein during a month, the delivered volumes of that Committed Shipper that exceed 60,000 barrels per day (on an average daily basis) will be charged a rate of [I] \$0.78 per barrel.
