ETHANE INCENTIVE PROGRAM

During a Month when the ethane percentage (%) of the Natural Gas Liquids tendered at a Receipt Point (averaged over the Month) for shipment on Carrier’s facilities exceeds the Base Ethane Level set forth in the table below (“Incremental Ethane”), the Incremental Ethane will be transported at an Ethane Incentive Program rate (rather than the rate that would otherwise apply). After the initial tariff publication, the Ethane Incentive Program rate will be published monthly at least five (5) Days prior to first Day of the Month of applicability.

If more than one Shipper at a Receipt Point tenders Incremental Ethane, the Incremental Ethane at the Receipt Point will be allocated to such Shippers pro rata based upon the total volumes of Natural Gas Liquids tendered at the Receipt Point.

All other volumes of Natural Gas Liquids tendered for shipment at a Receipt Point will be subject to the rates set forth in Carrier’s Local Volume Incentive Tariff No. 4.3 and successive issuances thereof. Carrier reserves the right to not publish an Ethane Incentive Program rate for any Month, in which case the Ethane Incentive Program will not apply during such Month.

Ethane Incentive Program Rate:

[W] Effective ~~June~~July 1 through ~~June~~July 30~~31~~, 2018 - No Ethane Incentive Program rate applicable during month. All Natural Gas Liquids transported by Carrier, including ethane, are subject to the rates set forth in Carrier’s Local Volume Incentive Tariff No. 4.3 and successive issuances thereof.
