A tender deduction of one-twentieth (1/20) of one percent (1%) by volume will be made on the quantity of Petroleum Products accepted for transported from East Houston, Galena Park, Pasadena-MVP or Texas City to Dallas, (Dallas County).

Exception to MPL's Texas No. **[W]** ~~49.14.0 49.13.0~~, Item 28-Transmix Handling and Item 30-Volume Correction and Tender Deductions shall apply to Item 400 herein: "Petroleum Product quantities transported will be adjusted to allow for inherent losses, including but not limited to shrinkage, evaporation, interface losses and other losses. Shipper shall bear actual loss allowances and any transmix for movements in Item 400. The pipeline loss adjustment will be made on the basis of total quantities transported."

Rates in cents per barrel of 42 United States Gallons each.
