INCREMENTAL POWER FEE (for all movements to Midway Station):

In any given month, for each barrel delivered over a daily average rate of 62,500 barrels per day but less than the daily average rate of 72,000 barrels per day, there shall be an incremental power fee of [U] forty-six and ninety-eight hundredths cents (\$0.4698) per barrel in addition to the transportation rates named herein.

In any given month, for each barrel delivered over a daily average rate of 72,000 barrels per day, there shall be an incremental power fee of [U] fifty-two and two tenths cents (\$0.5220) per barrel in addition to the transportation rates name herein.

UNLOADING CHARGE (applicable to all movements under this tariff Arrowhead Gath. Tariff No. 2.13): All shipments unloaded by tank trunk into the mainline facilities will be subject to a charge of [U] eight and thirty-five cents (\$0.0835) per barrel in addition to the transportation rates named herein.
