

**AMENDMENT NO. 3**  
**CONTRACT NO. 455-23-1017A FOR**  
**STATEWIDE LAB TESTING SERVICES**  
**BETWEEN**  
**THE RAILROAD COMMISSION OF TEXAS AND**  
**EUROFINS ENVIRONMENTAL TESTING SOUTH CENTRAL, LLC**

**THIS AMENDMENT NO. 3** to Contract No. 455-23-1017A (“Contract”) is entered into by and between the State of Texas, acting through the Railroad Commission of Texas (“RRC”), located at 1701 N. Congress Ave., Austin, Texas 78701 and Eurofins Environmental Testing South Central, LLC (“Vendor”), located at 4147 Greenbriar Drive, Stafford, Texas 77477 (individually “Party”; collectively “Parties”).

**WHEREAS, SECTION 7.06.** of the Contract provides the Parties may amend the Contract through written agreement; and

**WHEREAS,** on August 20, 2024, the Parties executed **Amendment No. 1** to the Contract to modify section **2.01. Contract Award.**, subparagraph (a.) to exercise renewal option one (1) of three (3) to continue the Contract through August 31, 2025, and to modify section **3.01. CONTRACT LIMIT, FEES AND EXPENSES.** changing the not-to-exceed amount of the Contract from SIXTY-FIVE THOUSAND DOLLARS AND ZERO CENTS (\$65,000.00) to ONE HUNDRED THIRTY THOUSAND DOLLARS AND ZERO CENTS (\$130,000.00), as approved by the Commissioners on August 15, 2024; and

**WHEREAS,** on August 15, 2025, the Parties executed **Amendment No. 2** to the Contract to modify section **2.01. Contract Award.**, subparagraph (a.) to exercise renewal option one (2) of three (3) to continue the Contract through August 31, 2026, and to modify section **3.01. CONTRACT LIMIT, FEES AND EXPENSES.** changing the not-to-exceed amount of the Contract from ONE HUNDRED THIRTY THOUSAND DOLLARS AND ZERO CENTS (\$130,000.00), to ONE HUNDRED NINETY-FIVE THOUSAND DOLLARS AND ZERO CENTS (\$195,000.00), as approved by the Commissioners on June 17, 2025; and

**WHEREAS,** San Antonio Testing Laboratory, LLC and Eurofins Environmental Testing South Central, LLC executed a Certificate of Merger on March 28, 2025, effective April 1, 2025; and

**WHEREAS,** pursuant to the merger, San Antonio Testing Laboratory, LLC was merged with and into Eurofins Environmental Testing South Central, LLC, with Eurofins Environmental Testing South Central, LLC as the surviving entity; and

**WHEREAS,** Eurofins Environmental Testing South Central, LLC has notified RRC of this change in ownership in accordance with Section 2.9.4.2.1 of RFP No. 455-23-1017A; and

**WHEREAS,** the Parties desire to further amend the Contract terms to their mutual benefit to reflect changed circumstances.

**NOW, THEREFORE,** the Parties agree to amend the Contract as follows:

- I. **Name Substitution.** All references in the Contract to “San Antonio Testing Laboratory, LLC” are hereby replaced with “Eurofins Environmental Testing South Central, LLC” the surviving entity in the merger, effective April 1, 2025.
- II. **Assumption of Obligations.** Eurofins Environmental Testing South Central, LLC agrees to assume all duties, responsibilities, liabilities, and obligations of San Antonio Testing Laboratory, LLC under Contract 455-23-1017A to the same extent as if it had been an original party thereto.

Except as expressly amended above, all provisions of the Contract, as amended, remain in full force and effect. In the event of a conflict among provisions of the Contract, the order of precedence shall be: this Amendment No. 3;

then Amendment No. 2; then Amendment No. 1; and then the original Contract in accordance with section **1.03. ORDER OF PRECEDENCE**., therein.

**IN WITNESS WHEREOF**, the Parties hereto have made and executed this Amendment No.3 to the Contract to be effective as of the date of the last Party’s signature hereto. By signatures below, each signatory represents and warrants that they have the authority to amend the Contract on behalf of the respective Party.
