AMENDMENT NO. 4 CONTRACT NO. 455-24-1003J FOR WELL PLUGGING & RELATED SERVICES BETWEEN THE RAILROAD COMMISSION OF TEXAS AND HOLMAN WELL SERVICE, LLC

THIS AMENDMENT NO. 4 to Contract No. 455-24-1003J ("Contract") is entered into by and between the State of Texas, acting through the Railroad Commission of Texas ("RRC"), located at 1701 N. Congress Ave., Austin, Texas 78701 and Holman Well Service, LLC ("Contractor"), located at 11401 Hwy 152 West, Pampa, Texas 79065 (individually, "Party"; collectively, "Parties").

WHEREAS, SECTION 7.06. of the Contract provides the Parties may amend the Contract through written agreement; and

WHEREAS, on August 27, 2024, the Parties executed Amendment No. 1 to the Contract to modify section 3.01. CONTRACT LIMIT, FEES AND EXPENSES. changing the not-to-exceed amount of the Contract from SIX MILLION DOLLARS AND ZERO CENTS (\$6,000,000.00) to TEN MILLION DOLLARS AND ZERO CENTS (\$10,000,000.00), as approved by RRC Commissioners on August 15, 2024.

WHEREAS, on October 9, 2024, the Parties executed Amendment No. 2 to the Contract to modify section 3.01. CONTRACT LIMIT, FEES AND EXPENSES. changing the not-to-exceed amount of the Contract from TEN MILLION DOLLARS AND ZERO CENTS (\$10,000,000.00) to SIXTEEN MILLION DOLLARS AND ZERO CENTS (\$16,000,000.00), as approved by RRC Commissioners on September 24, 2024.

WHEREAS, on August 15, 2025, the Parties executed Amendment No. 3 to the Contract to modify section 2.01. Contract Award., subparagraph (a.) to exercise renewal option one (1) of four (4) to continue the Contract through August 31, 2026, and to modify section 3.01. CONTRACT LIMIT AND FEES AND EXPENSES., changing the not-to-exceed amount of the Contract from SIXTEEN MILLION DOLLARS AND ZERO CENTS (\$16,000,000.00) to NINETEEN MILLION DOLLARS AND ZERO CENTS (\$19,000,000.00), as approved by RRC Commissioners on June 17, 2025.

WHEREAS, the Parties desire to further amend the Contract terms to their mutual benefit to reflect changed circumstances.

NOW, THEREFORE, the Parties agree to amend the Contract as follows:

I. **SECTION 3.01. CONTRACT LIMIT AND FEES AND EXPENSES.,** is deleted in its entirety and replaced with the following:

"CONTRACT LIMIT, FEES AND EXPENSES. The total amount of fees to be paid by RRC to Contractor under the Contract through the Contract Term shall not exceed TWENTY-NINE MILLION THREE HUNDRED FIFTY THOUSAND DOLLARS AND ZERO CENTS (\$29,350,000.00), the total of which includes the current NTE amount of NINETEEN MILLION DOLLARS AND ZERO CENTS (\$19,000,000.00), as approved by RRC Commissioners on July 17, 2025, plus the addition of TEN MILLION THREE HUNDRED FIFTY THOUSAND DOLLARS AND ZERO CENTS (\$10,350,000.00), as approved by RRC Commissioners on September 30, 2025."

Except as expressly amended above, all provisions of the Contract, as amended, remain in full force and effect. In the event of a conflict among provisions of the Contract, the order of precedence shall be: this Amendment No. 4; then Amendment No. 3; then Amendment No. 2; then Amendment No. 1; and then the original Contract in accordance with section **1.03. ORDER OF PRECEDENCE.**, therein.
