## **AMENDMENT NO. 1 CONTRACT NO. 455-25-1039 FOR** INTERAGENCY COOPERATION CONTRACT **BETWEEN** THE RAILROAD COMMISSION OF TEXAS AND THE NATIONAL JUDICIAL COLLEGE

THIS AMENDMENT NO. 1 to Contract No. 455-25-1039 ("Contract") is entered into by and between the State of Texas, acting through the Railroad Commission of Texas ("RRC"), located at 1701 N. Congress Ave., Austin, Texas 78701, and The National Judicial College ("NJC"), a Public Institution of Higher Education located at Judicial College Building/MS 358 Reno, NV 89557 (individually, "Party"; collectively, "Parties").

WHEREAS, SECTION 6.03. of the Contract provides the Parties may amend the Contract through written agreement; and

WHEREAS, the Parties desire to further amend the Contract terms to their mutual benefit to reflect changed circumstances.

NOW, THEREFORE, the Parties agree to amend the Contract as follows:

Ī. **SECTION 6.01. TERM.**, is deleted in its entirety and replaced with the following:

"This Contract shall be effective September 25, 2024 through August 31, 2026 (the initial term of the Contract plus the exercised optional renewal term one of three; collectively, "Contract Term") unless terminated earlier by either party, as provided in Section 6.02.

This Contract may be extended only through written amendment to the Contract, fully executed prior to the expiration of the Contract Term in effect prior to execution of the applicable amendment to the Contract.

RRC reserves the right to renew the Contract for two (2) additional, one-year renewal terms remaining of the original three one (1) year renewal terms as set forth below:

- Second Optional Renewal Term: September 1, 2026 August 31, 2027
- Third Optional Renewal Term: September 1, 2027 August 31, 2028"

Except as expressly amended above, all provisions of the Contract, as amended, remain in full force and effect. In the event of a conflict among provisions of the Contract, the order of precedence shall be: this Amendment No. 1; and then the original Contract.
