- (1) An incentive rate of [I] sixty-eight and seven tenths cents (68.70¢) per barrel will apply to any Shipper that has entered into and has an effective dedication agreement with Carrier or any Shipper shipping on behalf of a producer that has entered into and has an effective dedication agreement with Carrier with respect to service from Dora Roberts Central GS, Midland County, Texas to Midland Tank Farm, Midland, Texas.

Handling, Pumping, and Delivery Charge

An additional charge of [I] thirteen and eighty-six hundredths cents (13.86¢) per barrel will be made for delivery of Crude Petroleum through Carrier's system for injection into Plains Basin Pipeline or Enterprise Pipeline or the Energy Transfer Midland Terminal at Midland Tank Farm, Midland County, Texas for further movement to other destinations, provided that the above-referenced additional charge shall not apply to Barrels of Crude Petroleum that are nominated and delivered to the Wink to Webster Pipeline. An additional charge of [I] twenty and twenty-six hundredths cents (20.26¢) per barrel will be made for delivery of Crude Petroleum from the Midland Tank Farm, Midland County, Texas to Mesa Pipeline Midland Station.
