**Pumpover Charge:**

1. The carrier will not assess a pumpover charge for receipts of Crude Petroleum from connecting carriers at Midland Station, Midland County, Texas.
2. Where pumping service is performed by Carrier, an additional charge of [I] 16.01 cents per barrel will be made on all Crude Petroleum pumped to connecting carriers or facilities.

**Exceptions to the Rules and Regulations Tariff:**

**Rules 25(c) and 25(d)** - In lieu of the nomination due date contained in Rules 25(c) and 25(d) of the Rules and Regulations Tariff, the following will apply: nominations to the Carrier shall be made before 12:00 noon Central Standard Time/Central Daylight Saving Time, whichever is applicable, on the fifteenth (15<sup>th</sup>) of the month preceding the movement, as adjusted for weekends and Carrier Holidays pursuant to Rules 25(c) and 25(d).

**Rule 80** - In lieu of the 0.2% loss allowance deduction stated in Rule 80 of the Rules and Regulations Tariff, the following loss allowance deduction will apply: no loss allowance.
