- MOTOR VEHICLE LIABILITY:** The political subdivision named above self-insures for motor vehicle liability insurance coverage, pursuant to Texas Civil Statutes, Article 6701h, Sec. 33, and can render payments for motor vehicle liability judgments within the limits imposed by the Texas Natural Resources Code, Chapter 116 and the *Regulations for Compressed Natural Gas* adopted by the Railroad Commission of Texas.
