If I lose my qualified status as a transport driver with the state of Arkansas, Louisiana or New Mexico, my Texas examination exemption card will be returned immediately to the Commission and I will surrender all rights and privileges thereunder. I understand that this examination exemption accrues to me and is nontransferable.*

Additionally, applicant agrees that this application may be executed by electronic signature, which shall be considered as an original signature for all purposes and shall have the same force and effect as an original signature.

THIS EXEMPTION DOES NOT BECOME EFFECTIVE UNTIL AN EXAMINATION EXEMPTION CARD IS ISSUED TO YOU BY THE RAILROAD COMMISSION OF TEXAS. THIS CARD MUST BE AVAILABLE FOR INSPECTION AT ALL TIMES WHILE OPERATING AN LP-GAS TRANSPORT IN TEXAS.
