AMENDMENT NO. 1 CONTRACT NO. 455-24-1003T FOR WELL PLUGGING & RELATED SERVICES BETWEEN THE RAILROAD COMMISSION OF TEXAS AND RED DIRT ENERGY, LLC

THIS AMENDMENT NO. 1 to Contract No. 455-24-1003T ("Contract") is entered into by and between the State of Texas, acting through the Railroad Commission of Texas ("RRC"), located at 1701 N. Congress Ave., Austin, Texas and Red Dirt Energy, LLC ("Contractor"), located at 3909 N. Classen Blvd. Suite 400, Oklahoma City, Oklahoma 73118 (individually, "Party"; collectively, "Parties").

WHEREAS, SECTION 7.06. of the Contract provides the Parties may amend the Contract through written agreement; and

WHEREAS, the Parties desire to further amend the Contract terms to their mutual benefit to reflect changed circumstances.

NOW, THEREFORE, the Parties agree to amend the Contract as follows:

1. 3.01. CONTRACT LIMIT AND FEES AND EXPENSES., is deleted in its entirety and replaced with the following:

"CONTRACT LIMIT, FEES AND EXPENSES. The total amount of fees to be paid by RRC to Contractor under the Contract through the Contract Term shall not exceed TWO MILLION FIVE HUNDRED THOUSAND DOLLARS AND ZERO CENTS (\$2,500,000.00), the total of which includes the current NTE amount of ONE MILLION FIVE HUNDERED THOUSAND DOLLARS AND ZERO CENTS (\$1,500,000.00), as approved by the RRC Commissioners on March 19, 2024, plus the addition of ONE MILLION DOLLARS AND ZERO CENTS (\$1,000,000.00), as approved by the RRC Commissioners on September 24, 2024."

Except as expressly amended above, all provisions of the Contract, as amended, remain in full force and effect. In the event of a conflict among provisions of the Contract, the order of precedence shall be: this Amendment No. 1; and then the original Contract in accordance with section **1.03. ORDER OF PRECEDENCE.**, therein.
