Centurion notes that shippers delivering Crude Petroleum to the receipt points at Andrews Station, Cedar Lake Inj., Flanagan Station, Goldsmith GS Inj., Mallet Station, Seminole Station, and Wasson Station will continue to have the ability to access the Magellan Crane Terminal in Crane, Texas by nominating and shipping under Centurion [W] TX No. 30.2.0 ~~30.0.0~~ or subsequent reissues thereof (which governs movements from the above-noted receipt points to Midland Tank Farm) and Centurion F.E.R.C. No. 2.8.0 or subsequent reissues thereof (which governs movements from the Midland Tank Farm to the Magellan Crane Terminal in Crane, Texas).

Gathering Charges: For gathering charges into points of origin above except Goldsmith GS Inj., see Centurion TX No. [W] 13.24.0 and TX No. 30.2.0 ~~13.23.0~~ and No. ~~30.0.0~~, supplements thereto or reissues thereof. Gathering charges into Goldsmith Inj. are included in the rate for this origin point listed above in the Table of Rates.
