GATHERING CHARGE: Where gathering service is performed by Carrier at point of origin, a charge of **[C]** 100.21 cents per barrel will be made in addition to the transportation rate named herein.

INCENTIVE GATHERING RATE: At Cedar Lake and Sands Station WTS, a **[C]** 65.70 cent per barrel incentive gathering charge will apply to barrels of Crude Petroleum gathered in excess of 4,000 barrels per day by a shipper. The barrels per day will be calculated based on the monthly volume. The Incentive Gathering rate does not apply to Crude Petroleum gathered from the Sundown Helen Leases into Sundown Station.

HAND RUN GAUGING FEE: There will be an additional charge of **[C]** 42.20 cents per barrel on gathered Crude Petroleum which is hand run gauged.

TRUCK UNLOADING CHARGE: Crude Petroleum unloaded from tank truck into Carrier's facilities will be subject to a charge of **[C]** 11.21 cents per barrel.
