**INSTRUCTIONS**

**Reference: Chapter 4 Division 10 §4.193(e)**

**WHO MUST FILE**

A person who transports oil & gas waste for hire by any method other than by pipeline off a lease, unit, or other oil & gas property for disposal is required to have a waste hauler permit per §4.193 (a).

**APPLICATION FEES**

A non-refundable fee of \$250 must be filed with an initial application and a renewal application.

**INITIAL PERMIT APPLICATION**

The applicant must have an active P-5 Organization Report with the appropriate financial security on file before an initial permit is accepted.

Form WH-1 Application for Waste Hauler Permit, and Form WH-2 Waste Hauler List of Vehicles are required for the initial application.

Online filing is the preferred method in [LoneSTAR](#) on the RRC website.

An auto-generated notice is sent to the email on file with the Commission 60 days before the permit expiration date.

**RENEWAL PROCEDURES**

Form WH-1 Application for Waste Hauler Permit and Form WH-3 Waste Hauler Authority to Use Approved Disposal/Injection System are required for the renewal.

Form WH-2 is only required if additional haulers are added to the permit.

**GENERAL INSTRUCTIONS**

Upon approval of the completed application, a permit will be issued, including Appendix A (Approved Injection Disposal Systems), Appendix B (Approved Surface Disposal Systems), and Appendix C (Approved Vehicles).

The permittee must file a Form WH-3 with the Commission in Austin before using any system that is not shown on Permit Appendix A (Approved Injection Disposal Systems) or Permit Appendix B (Approved Surface Disposal Systems).

Each ***hauler must carry a copy of the complete Waste Hauler Permit***, including attachments Appendix A (Approved Injection Disposal Systems), Appendix B (Approved Surface Disposal Systems), and Appendix C (Approved Vehicles).
